## Pupil Premium 2017—2018

### 1. Background

The Pupil Premium is a government initiative which began in 2011, and which is designed to support children who are deemed to be from a disadvantaged background. Money is paid to the school which is then used to target resources in a way which benefits these children. Children who have been on Free School Meals (FSM) at any point over the past six years, and any children who have been in care for 1 day or more are provided for through Pupil Premium.

In the academic year 2016—2017, Pupil Premium had a value of £1320 per child and £1900 for Looked After Children. This has changed for this academic year to £1320 for Pupil Premium children and £2300 for Looked After Children.

The government has never dictated what the money has to be spent on, but what is clear is that money needs to be used to narrow the gap between the highest and lowest achieving pupils, and that it is for the school to decide the best way for this to happen.

Our school vision states that we '**nothing but the best is good enough**;' for all children. It also states following our Christian values are children will be:

**'Ready for life,'**

regardless of what nature this disadvantage takes. This document sets out our plans for how we have used and will use the Pupil Premium to overcome disadvantage and 'narrow the gap.'

## 2. 2017-2018

### 2.1 Pupil Premium Funding

In the academic year 2017-2018, Heckington St Andrew's Church of England Primary School received £40,540 in Pupil Premium funding.

### 2.2 Narrowing the gap: a brief overview

Heckington St Andrew's Church of England Primary School is an average sized village primary school of around 180 children. Details of the cohort in September 2017 is shown below.

There is no single intervention which provides a complete solution to narrowing the gap, or to supporting our disadvantaged children in the way that suits them best. Using evidence-based research from the Education Endowment Foundation (EEF), we try to take a range of approaches to effectively spend and invest the Pupil Premium money to have maximum impact on closing the gap of attainment for our disadvantaged children. We regularly review the impact of the Pupil Premium spending and share key updates each term with our Pupil Premium Champion Governor. Updates are also provided to the full governing body through termly Head Teacher updates.

On the next page there is a detailed breakdown of how the money was spent in the 2017-2018 academic year.

In addition to the Pupil Premium money, many of our school systems were already in place to support children from all backgrounds and of all abilities, including:

- Pupil Progress meetings, which take place 6 times a year to discuss all children in school with regard to both their academic attainment and pastoral issues.
- An effective assessment, monitoring and tracking system that allows us to identify any children or groups of children who were not making sufficient academic progress.
- Utilising a range of teaching strategies employed by staff in the school to enable all children to make progress and to cater for a wide range of needs.

### 3.1 Pupil Premium Objectives and Spending 2017-2018

### Low cost - High impact

The work that our CASY Counsellor and Play therapist carries out is essential in ensuring that our most vulnerable learners (and their families) attend school and make progress in their learning. The role that they carry out is varied and tailored to the needs of the individual children and their families. They build positive working relationships with some of our most challenging families and mentoring of children play is a highly significant role in supporting children to overcome any barriers to allow them to access the curriculum and make progress. Our CASY counsellor has also worked with groups of children especially in Upper Key Stage 2 to work on a game called Healthy Living as well as providing small group nurturing sessions.

Due to the positive impact of this spending, it will continue as the school moves into a new academic year

Ensuring that all children attend school is fundamental in the work that we do at Heckington St Andrew's Church of England Primary School. Although we have not seen an impact this year towards the end of the school year we could see a slight improvement. This will be developed over the coming year. We have now ensured letters are sent to parents sooner to enable us to catch them earlier. This year due to timing of implementation we only held a small number of attendance meetings. Nationally, when comparing Persistent Absenteeism between Pupil Premium and non-Pupil Premium children (2016-2017), the percentage of Pupil Premium children's PA is more than twice that of non-Pupil Premium children's. However, at Heckington St Andrew's Church of England Primary School: Pupil Premium PA for 2016-2017 was 29.6% compared to non-Pupil Premium at 7.2%. There is still work to be carried out to improve the attendance of vulnerable learners but with new systems in place then we should see a positive impact.

### High cost - High impact

The purchasing of high interest differentiated reading books for EYFS and KS1 has proven invaluable, our reading data below can clearly show the impact on the reading it is having. The comments from the children about how they now enjoy going to choose a book and look forward to sharing it with adults in school and adults at home.

During the 2018-2019 academic year, we will look at developing our reading books for KS2 to ensure the children are interested and want to read which in turn will support the development in the reading data.

### High cost - High impact

Inspirations and aspirations play a pivot role in the curriculum at Heckington St Andrew's Church of England Primary School and this is vitally important for our Pupil Premium children as we look to enable social mobility by providing children with rich experiences (both in and out of school) to inspire our learners. We use the Pupil Premium budget to subsidise trips and enrichment opportunities to ensure that children are able to participate in activities. Throughout the year the school offers a wide range of experiences to the children.

The Pupil Premium budget plays an invaluable role in ensuring that we provide children with highly inspirational activities to spark their learning. This year we invested some of our money into providing music lessons for our Pupil Premium children. The children also enjoyed performing to family, friend and the community at St Andrew's Church during the Spring Term.

### High cost - High impact

At Heckington St Andrew's Church of England Primary School, we continue to invest a significant proportion of the Pupil Premium budget on staffing as we have seen the impact this can make to narrowing the gap between disadvantaged children and their peers and also at raising attainment. We utilise pupil progress meetings to identify, monitor and track vulnerable learners. These meetings are used to establish and implement intervention opportunities for these children. The budget was used to employ an intervention teacher on a 0.4 contract. The impact of this intervention and support can be seen from the tables below.

The impact of support provided for Pupil Premium children in Year 6 is evident from the SATs results. Through careful analysis of key data and information, children are identified through Pupil Progress meetings and on-going assessment for learning in the classroom and are supported through a range of interventions including:

- ⇒ Extra-curricular one to one tuition sessions
- ⇒ Bespoke intervention and support programmes (delivered by class teacher)
- ⇒ Teaching assistant intervention
- ⇒ Small group teaching for reading, writing and maths during the morning sessions

Below is a summary of the impact of this spending. It is clear that those children who are Pure PuP (and not also SEN or EAL) are performing better than the rest of the cohort. This is also supported by the average scaled scores that the children in achieved in the SATs papers for reading, maths and grammar, punctuation and spelling.
